Dear Colleagues,

This has reference to the monthly report on 'Monitoring of filing of appeals by field formations.

2. The reports for the month of February, 2023 (containing data for January, 2023), have been collated. Detailed Analysis Report is enclosed as Annexure- A. It is observed that although there is a decline in 'Supercritical and critical' cases of High Court orders vis a vis January 2023, the number of cases are still quite high. Prompt action for examining the orders as envisaged is yet to gain ground.

3. A statement with grading system about timely disposal and submission of reports is also enclosed as Annexure-B1, B2 & C1, C2. Only 6 zones disposed of all High Court/CESTAT orders received during the month. **This needs to improve substantially.**

4. It is requested to ensure that there are no cases in the critical/ Super-critical category.

Detail Analysis Report **(for February 2023)**

Scrutiny of the reports reveals that :-

(a) Only 6 following zones disposed of all High Court/ CESTAT orders received during the month.

- Customs Trichy Prev.
- CGST Hyderabad
- CGST Lucknow
- CGST Shillong/Guwahati
- Customs Delhi Prev.
- Customs Patna Prev.

(b) The total number of **High Court orders** cases where decision is pending for acceptance or otherwise is 67.

Out of this, 11 cases (16.41%) fall under 'Super critical' category and 19 cases (28.35%) in 'Critical' category. As such, 44.77% of the total orders are awaiting decision on acceptance beyond the prescribed timelines.

Zones with highest pendency in 'Super Critical' category are as under:-

- CGST Bengaluru **(02 cases/18.18%),**
- CGST Bhubaneswar **(02 cases/18.18%),**
- CGST Chennai **(02 cases/18.18%),**
- Customs Mumbai-II **(02 cases/18.18%),**

Zones with highest pendency in 'Critical' category are as under:-

- CGST Thiruvananthapuram **(10 cases /52.63%)**
- CGST Bhubaneswar **(03 cases/15.78%),**
- CGST Delhi **(03 cases/15.78%),**
- CGST Pune **(02 cases/10.52%)**

(c) The total number of **CESTAT orders** cases where decision is pending for acceptance or otherwise is 388.

Out of this 210 cases (54.12%) fall under 'Super critical' category and 134 (34.53%) in 'Critical' category. As such, 88.65% of

the total orders are pending decision on acceptance or otherwise beyond the prescribed timelines.

Zones with highest pendency in 'Super Critical' category are as under:-

- CGST Vadodara **(109 cases/51.90%),**
- CGST Delhi **(24 cases/11.42%),**
- CGST Kolkata **(17 cases/8.09%),**
- CGST Bhopal **(10 cases/4.76%),**

Zones with highest pendency in 'Critical' category are as under:-

- CGST Vadodara **(40 cases/29.85%)**
- CGST Nagpur **(17 cases/12.68%)**
- CGST Mumbai **(16 cases/11.94%)**
- CGST Delhi **(14 cases/10.44%)**

(d) Only 26 of the 32 zones sent the report in time.
