Dear *Colleague,*

An analysis of the Zonal performance in timely filing/processing of appeal cases over the period April, 2024 has been carried out (analysis sheets enclosed as Annexure-A, A1, A2).

2. Detailed Analysis of the monthly report on filing of appeals by field formation for May 2024 (containing data for April 2024) is also enclosed herewith (as Annexure-B). A statement with grading about timely disposal and submission of report has been prepared as Annexure-B1, B2, C1, and C2. It is observed that only 02 Zones (CGST Jaipur and Customs Delhi Prev.) have disposed of all the High Court/CESTAT orders received during April, 2024 within the prescribed timelines.

3. Needless to state that the cases figuring in 'Critical' and 'Super Critical' category in High Court and CESTAT respectively need closer attention for ensuring time-bound action.

4. The Zonal Principal Chief Commissioners/Chief Commissioners are again advised to ensure regular monitoring of High Court and CESTAT websites followed by prompt action in deserving cases so that no case figures in 'Critical' and 'Super Critical' category, in line with the Hon'ble Supreme Court's directions.

Detailed Analysis Report **(for May, 2024)**

Reports for May, 2024 (containing data for April, 2024) on filing of appeals have been received and examined.

2. Scrutiny of the reports reveals that:-

(a) The total number of **High Court orders** where decision is pending for acceptance or otherwise is 142.

Out of this, 70 cases (49%) fall under 'Super critical' category and 24 cases (17%) under 'Critical' category. As such, 66% of the total orders are awaiting decision on acceptance beyond the prescribed timelines.

Zones with highest pendency in 'Super Critical' category are as under:

CGST Guwahati	(14 cases/20%)
Customs Ahmedabad	(12 cases/17%)
CGST Chennai	(10 cases/14%)

Zones with highest pendency in 'Critical' category are as under:-

CGST Mumbai	(04 cases/17%)
Customs Delhi	(04 cases/17%)
CGST Kolkata	(03 cases/13%)
Customs Nagpur	(03 cases/13%)

(b) The total number of **CESTAT orders** where decision is pending for acceptance or otherwise is 923.

Out of this 488 cases (53%) fall under 'Super critical' category and 272 cases (29%) in 'Critical' category. As such, 82% of the total orders are pending decision on acceptance or otherwise beyond the prescribed timelines.
